In order to progress my application for employment as seafarer through Marine Partners Monaco SAM or any subsidiary (further referred to as “the Company”) I hereby give my explicit consent for the Company to collect, process, store, hold, transfer, and use my personal information, including any special category of personal information as relevant, required and appropriate to my request for employment.

In order to review and process my request for employment and to comply with any lawful mandatory requirements, my personal details may be provided to Ship-owners, Authorities, Classification societies and any other third parties as applicable and relevant. Such information shall include, but not limited to, identification documents, professional qualifications, trainings, previous sea service, personal photograph, Curriculum Vitae, Health data, previous land based experience and recruitment information such as interviews and test results.

It is my responsibility to provide any updated information to the Company relevant to my application for employment. I accept that upon being offered employment by the Company, the Company will have the right to keep records of any of my personal information including but not limited to any relevant personal information needed for the performance of my employment contract. I understand that I should communicate to the Company any changes concerning my personal information relevant to my employment. The Company will have legitimate use of my amended personal information and the right to verify that given data/information are accurate.

I acknowledge that I have a legal right under the data protection law to see any of my personal information kept by the Company and that I also have the right to rectify any inaccurate information by providing the right evidence. I also acknowledge my entitlement, at any time, to withdraw my consent to any further processing of my personal information held by the Company in accordance with my lawful rights.

I understand that all my personal data will be kept only as long as necessary and processed in a manner that such information shall be subject to privacy requirements and the security of my personal data should be maintained at all times. The Company will have in place measures against unauthorized or unlawful processes, accidental loss, destruction or damage by using appropriate technical or organizational measures.

I hereby confirm that I have read and understood and agree to the processing of my personal data or any special category of personal information for reasons as outlined above, as required for the performance of my Seafarer Employment Agreement (SEA), notwithstanding that my explicit consent may not be required by virtue of Article 6 (a) to (e) and Articles 9 and 10 of the General Data Protection Regulation (GDPR).
